Sir,



Post Matric Scholarship shall be disbursed to the students observing all guidelines and orders issued by this Department from time to time.

This order issues in exercise of the powers delegated under Finance Department's Memo No. 1872-F.B. dated 26/03/2018, read with concurrence of Financial Advisor of this department vide his U.O. No. 07/FA/BCW dated 25/04/2018.


