Schemes-006-Promotion of Cultural Activities [SC]-02-Wages" (Code : "07-2225-01-800-006-V-02") from the Budgetary Provision of the current financial year i.e. 2024-25.

I am also directed to add that allotment of funds is no authority to incur expenditure without previous sanction of Government where such sanction is necessary under the standing rules and orders.


