The Technical Presentation shall be held at the **Conference Hall** of the Corporation at its registered office at **CF-217/A/1, Sector-I, Salt Lake City, Kolkata – 700 064**, where authorized representatives of the bidders shall be required to be physically present for giving the presentation using **Microsoft Power Point**, in English / Bengali vernacular. The shortlisted bidders will be marked by the Selection Committee on a maximum of 20 marks as per marking methodology given below:



Supervision and monitoring framework	0 - 10

The bidders will be required to demonstrate the following during the Technical Presentation for marking purpose:

- A. Sector of interest, prior experience in such sector of interest, valid affiliation with Sector Skill Council(s) in their preferred sector of interest.
- B. Job roles in sectors of interest, expertise in such job roles, capacity to take up multiple assignments.
- C. Presence in 2 or more districts of West Bengal, preference of districts, existing arrangement in situ of the districts, valid tie ups for undertaking training in such districts.
- D. Statement of purpose for implementation of training programmes.
- E. Placement strategy.
- F. Quality control mechanisms, Monitoring mechanism, indicative use of appropriate Computer Applications for monitoring.

The overall time period for Technical Presentation is capped at 15 minutes out of which 5 minutes shall be used by the bidders for their presentation and 10 minutes shall be used for replying to the questions put by the Selection Committee to the bidders.

Decision of selection committee shall be final and binding. Merely appearing in Technical evaluation session doesn't confer any right of being selected or empanelled.


